I. PROVISION OF SERVICE

The contractor shall provide and deliver high grade fuel to the U.S. Embassy Phnom Penh, warehouse, residences and other locations within Phnom Penh municipality as described in this solicitation. The contract type will be a fixed price with economic price adjustment indefinite quantity/indefinite delivery under which may be placed firm fixed-price delivery orders.

The price listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, profit, and transportation necessary to supply and deliver to the American Embassy Phnom Penh compound, residences and other places within Phnom Penh, CAMBODIA duty free and without VAT, and supply GASOLINE and DIESEL to government-owned CD25 plated vehicles and privately-owned CD25 plated vehicles at contractor's gas stations throughout CAMBODIA duty free and without VAT.

In consideration of satisfactory performance of all scheduled services required under this contract, the contractor shall be paid a firm fixed-price for each delivery. The contractor shall be compensated monthly upon receipt of a proper invoice for all deliveries made under delivery orders during the month. The contract type will be a fixed price indefinite quantity/indefinite delivery under which may be placed firm fixed-price delivery orders.

Firms are required to submit offers in USD and be paid in USD.

Price Adjustment: Prices shall be adjusted every quarter, based on increases or decreases in the official retail prices issued on bi-weekly basis by the Ministry of Commerce, the Cambodian government. In adjusting the prices, the Contractor shall take into account factors such as fuel prices announced by the Cambodian government, prices without import tax/VAT, market prices, discount, and other direct costs relating to implementing this contract.

The Contractor shall provide written notification of the adjusted prices at least two weeks prior to the next quarter/before the new prices are to be effective. This notification must be accompanied by a copy of the official announcement of the price change issued by the Ministry of Commerce.

III. IMPORT AND VALUE ADDED TAX

Value Added Tax (VAT) and Import Tax are not applicable to this contract and shall not be included in the rates or invoices because the U.S. Embassy has a tax exemption certificate from the Cambodian government.

IV. SCOPE OF WORK

For the period of the contract, the U.S. Government guarantees a minimum order of **30,000 liters of Diesel and 100,000 liters of Gasoline (Super and Regular)**. The maximum amount ordered under this contract shall not exceed **180,000 liters of Diesel and 240,000 liters of Gasoline (Super – 30,000 liters and Regular-210,000 liters)**. The contracting officer may issue oral orders that will be confirmed in writing.

The fuel provided will be **high grade diesel fuel (Cetane Index, min 45) and Gasoline (Octane Number, min 92 for Regular and min 95 for Super)**. For supply and delivery of diesel fuel and gasoline, the contractor shall be paid the fixed price per unit as listed above upon receipt of monthly invoices. For the supply of the gasoline and diesel to the privately-owned CD25 plated vehicles at the gas stations throughout Cambodia, the contractor shall be paid for the purchase at the fuel pump with duty free and without taxes.

V. DELIVERY

The contractor shall deliver diesel fuel to the U.S. Embassy located at **# 1, Street 96, the Embassy warehouse, and other locations within Phnom Penh municipality**. Requirements of delivery are as follows:

- Upon requirement, the delivery schedule of diesel to the Embassy's compound will be notified by the Embassy in advance. Actual quantities will be specified in delivery order and sent to the Contractor 3 days prior. Fuel tank requirements will depend on the size of the order.
- Occasional delivery orders are anticipated for the delivery of diesel to different locations including the Embassy's warehouse and several residences. The delivery orders will be issued approximately 10 times per year and each order will be a minimum of 500 liters and a maximum of 3,000 liters. The delivery requires truck tank capacity according to the order. There is no requirement of delivery of diesel to different locations on the same day. All locations are within Phnom Penh downtown areas and the maximum distance between delivery destinations does not exceed 5 km.
- Upon requirement of diesel and/or gasoline, the contractor shall provide fuel cards for 20 liters and 50 liters at the contract prices. The Embassy will issue delivery order specifying the amounts of order.
- The contractor shall promptly deliver the fuel by tanker truck on the date and time that are specified on delivery orders issued under the contract.

- Both diesel and gasoline are required for refueling the Government and privately owned CD25 plated vehicles at the gas stations and no deliveries will be required.
- Any contractor personnel involved in the delivery of the fuel shall comply with Embassy regulations for receiving supplies. The Contracting Officer's Representative (COR) will be responsible for instructing contractor personnel at the time deliveries are made. The driver of the tanker truck must submit an invoice to the COR for approval at the time any delivery is made.

The contractor shall provide Super and Regular gasoline to CD 25 vehicles that meet the specifications as below:

The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

IX. QUALITY CONTROL REQUIREMENT

- A. The contractor is required to submit a written test certification for quality assurance of the diesel and gasoline (super and regular) on a quarterly basis to the COR.
- B. COR shall be allowed access/visit to its depot to randomly observe fuel loading procedures.
- C. At the request of COR, the contractor shall provide truck tank specification including method of gauging the tank that is consistently used to transport the fuel to the Embassy.
- D. The contractor shall provide gasoline (super and regular) consumption report of all government owned CD 25 plated vehicles and privately-owned CD25 plated vehicles separately on a quarterly basis to the COR.

(c)(1) If the Contractor is a foreign person and has only a partial or no exemption to the withholding, the Contractor shall include the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, with each voucher or invoice submitted under this contract throughout the period in which this status is applicable. The excise tax withholding is applied at the payment level, not at the contract level. The Contractor should revise each IRS Form W-14 submission to reflect the exemption (if any) that applies to that particular invoice, such as a different exemption applying. In the absence of a completed IRS Form W-14 accompanying a payment request, the default withholding percentage is 2 percent for the section 5000C withholding for that payment request. Information about IRS Form W-14 and its separate instructions is available via the internet **at www.irs.gov/w14**.

(2) If the Contractor is a foreign person and has indicated in its offer in the provision 52.229-11, Tax on Certain Foreign Procurements—Notice and Representation, that it is fully exempt from the withholding, and certified the full exemption on the IRS Form W-14, and if that full exemption no longer applies due to a change in circumstances during the performance of the contract that causes the Contractor to become subject to the withholding for the 2 percent excise tax then the Contractor shall—

(i) Notify the Contracting Officer within 30 days of a change in circumstances that causes the Contractor to be subject to the excise tax withholding under 26 U.S.C. 5000C; and

(ii) Comply with paragraph (c)(1) of this clause.

(d) The Government will withhold a full 2 percent of each payment unless the Contractor claims an exemption. If the Contractor enters a ratio in Line 12 of the IRS Form W-14, the result of Line 11 divided by Line 10, the Government will withhold from each payment an amount equal to 2 percent multiplied by the contract ratio. If the Contractor marks box 9 of the IRS Form W-14 (rather than completes Lines 10 through 12), Contractor must identify and enter the specific exempt and nonexempt amounts in Line 15 of the IRS Form W-14; the Government will then withhold 2 percent only from the nonexempt amount. See the IRS Form W-14 and its instructions.

- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Reasonable inquiry has the meaning provided in the clause 52.204–25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

Successor means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. 52.229-11 TAX ON CERTAIN FOREIGN PROCUREMENTS—NOTICE AND REPRESENTATION (JUN 2020)

(a) *Definitions*. As used in this provision—

Foreign person means any person other than a United States person.

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701(a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.

(d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—

(1) It is is not a foreign person; and

(2) If the Offeror indicates “is” in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14 a full exemption, or partial or no exemption [*Offeror shall select one*] from the excise tax.

(e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

652.225-70 ARAB LEAGUE BOYCOTT OF ISRAEL (AUG 1999)

(a) Definitions. As used in this provision:

Foreign person means any person other than a United States person as defined below.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

- (b) Certification. By submitting this offer, the offeror certifies that it is not:
- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
 - (2) Discriminating in the award of subcontracts on the basis of religion.
