The U.S. Embassy, Phnom Penh will hold an auction of a used vehicle for the general public.

Location of the Sale

U.S. Embassy Phnom Penh, Address: #1, Street 96, Sangkat Wat Phnom, Khan Daun Penh, Penh. Due to the current social distancing policy, the vehicle shall not be allowed to physically be inspected, but interested bidders still can view the pictures of it and should they have any questions, they may ask via the contact telephone number at the end of this announcement.

During the above period, interested bidders shall mail in their bidding slip, clearly stating the amount that they wish to bid (do not include tax amount), full name, contact telephone number, and a copy of I.D. card or passport.

Conditions of Sale

- ✓ The vehicle will be sold to the highest bidder through a sealed bid process.
- ✓ Vehicle is sold on an as-is, where-is, non-returnable basis for cash payment without refund or warranty.
- ✓ The U.S. Embassy Phnom Penh reserves the right to reject any bid that is considered not to be commensurate with the value of the vehicle, or to reject any bid where there is evidence of connivance, collusion, or bribery.
- ✓ Payment: Successful bidders will have to make a full payment and non-refundable within 72 hours of the notification, to the U.S. Embassy's bank account. The details on how to pay will be instructed to the winning bidder. Any NGOs, international organizations, or RGC ministries can consult the RGC customs officers for tax-exempt procedures.
- ✓ All duties and taxes are the responsibilities of the bidders. The import tax rate is determined by the Cambodian Customs and Excise authority. The applied tax rate for this vehicle, 1998 Toyota Land Cruiser, CD25-166, is 152.45%. The import tax calculation is by multiplying the winning bid amount with the defined tax rate of each vehicle.
- ✓ The minimum bid for this vehicle, 1998 Toyota Land Cruiser, CD25-166, is 2000 USD.
- ✓ All arrangements and costs to remove the purchased vehicle are the responsibility of the buyer.
- ✓ In the event the purchaser fails to remove the purchased vehicle from the sale site by 5:00 p.m. August 14, 2020, the U.S. Embassy Phnom Penh, at its election, shall be entitled to charge progressive storage rates up to the bid value, after which the winning bidders shall forfeit the right to the purchased vehicle and all payments made.
- ✓ In order to remove the purchased vehicle from the sale site, the bidder must present a signed receipt issued by the U.S. Embassy cashier showing payment in full, and a copy of the customs tax payment or a copy of a tax exempt document (for entities claiming tax-exempt eligibility).

- ✓ U.S. Embassy employees involved in logistical operations of the auction are prohibited from bidding on any vehicle.
